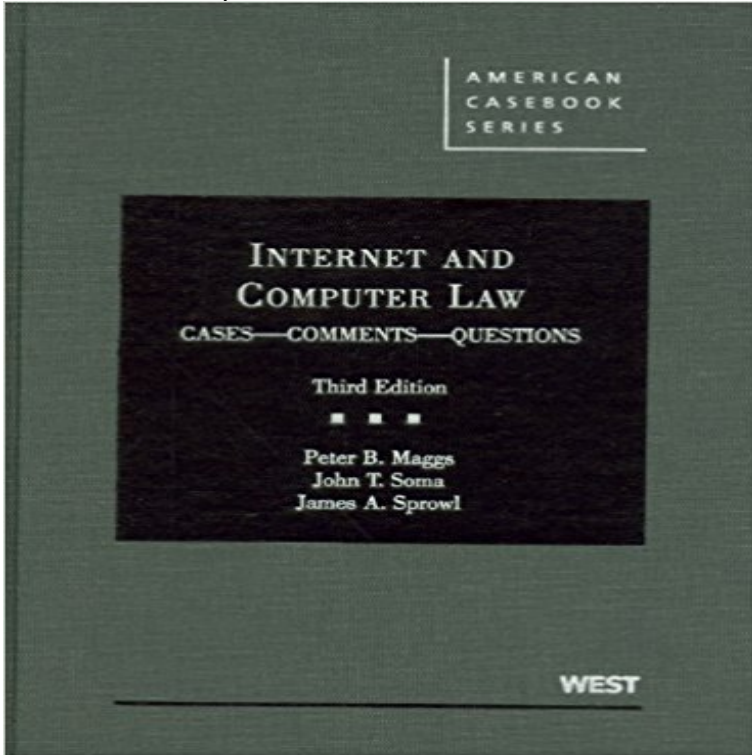


# Internet and Computer Law, Cases, Comments, Questions, 3d (American Casebooks)
