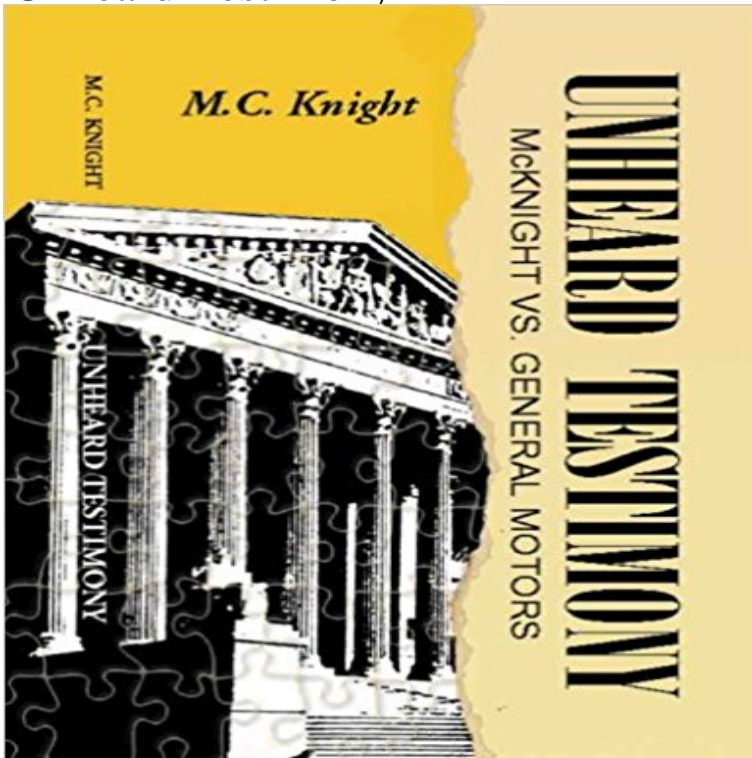


# Unheard Testimony
