Starting from the premise that ecological sustainability requires environmental law systems to be sensitive to a wide array of institutional, social, and economic issues, and to emerging forms of environmental governance beyond conventional legal regulation, the book explores: future directions in command regulation, changing forms of public administration, risk assessment and precautionary regulation, ecological justice, public participation in environmental decision-making, indigenous peoples and the environment, industry self-regulation, economic instruments, sustainable finance, the state of international environmental law, and environmental law in developing countries.
