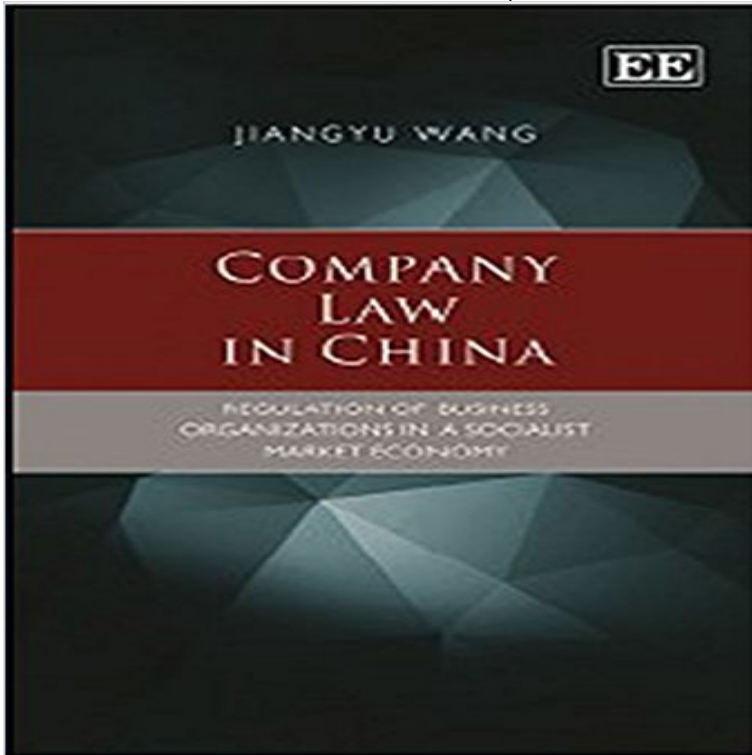


# Company Law in China: Regulation of Business Organizations in a Socialist Market Economy
