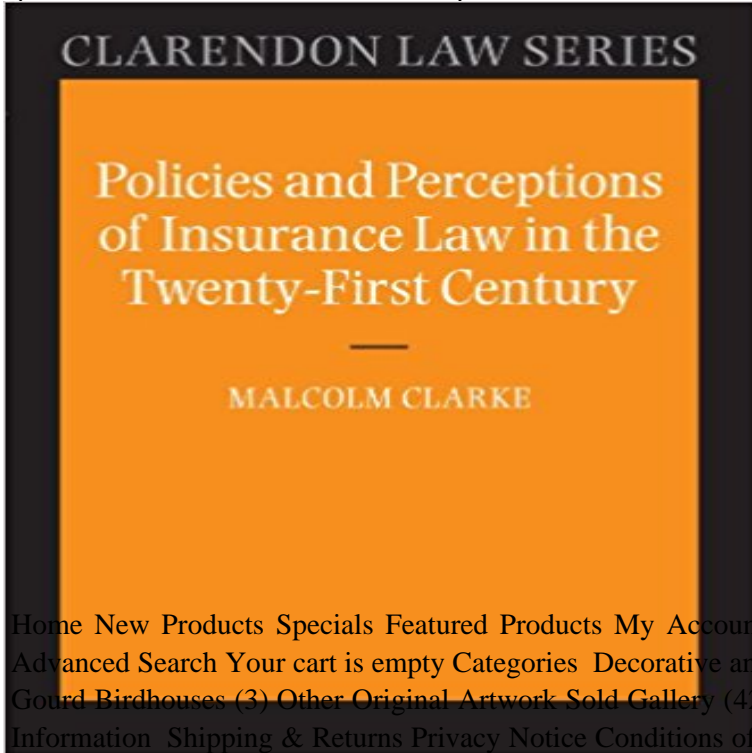


Policies and Perceptions of Insurance Law in the Twenty First Century (Clarendon Law Series)
