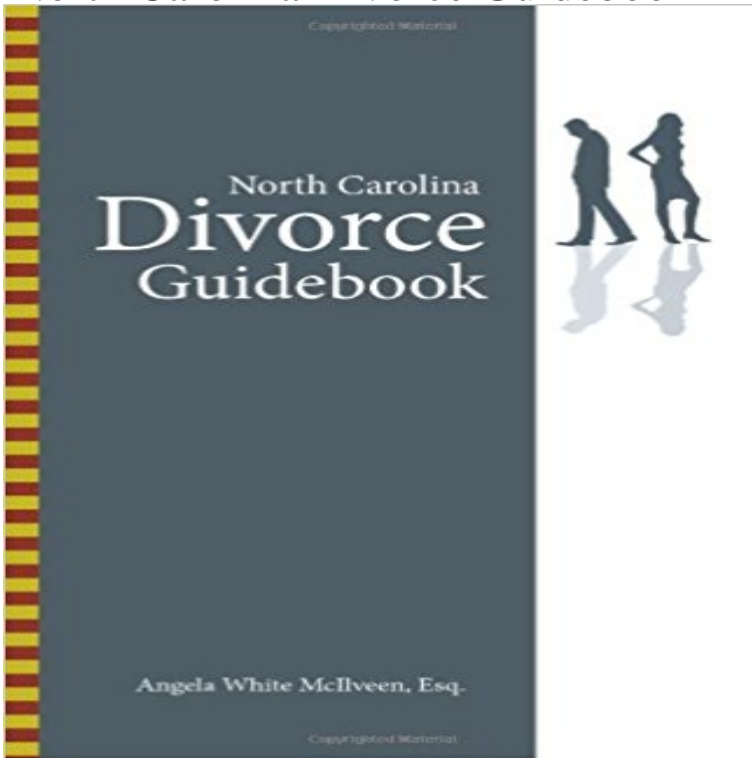


North Carolina Divorce Guidebook
