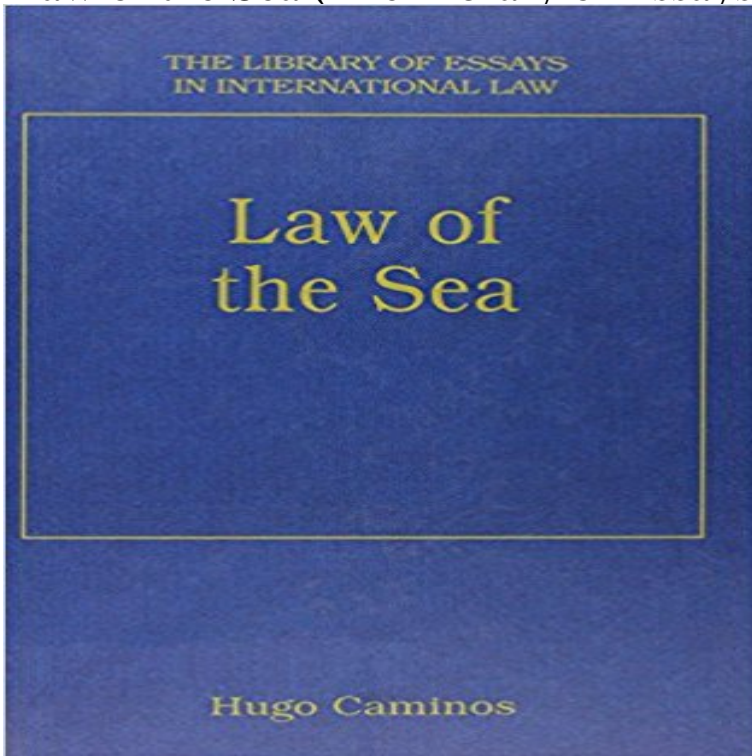


Law of the Sea (The Library of Essays in International Law)
