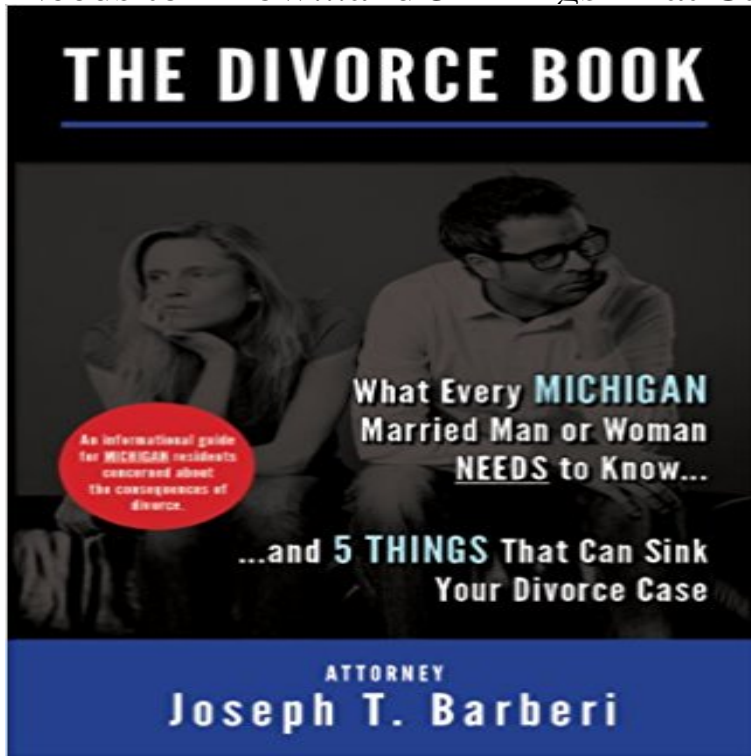


# The Divorce Book: What Every Michigan Married Man or Woman Needs to Know...and 5 Things That Can Sink Your Divorce Case
