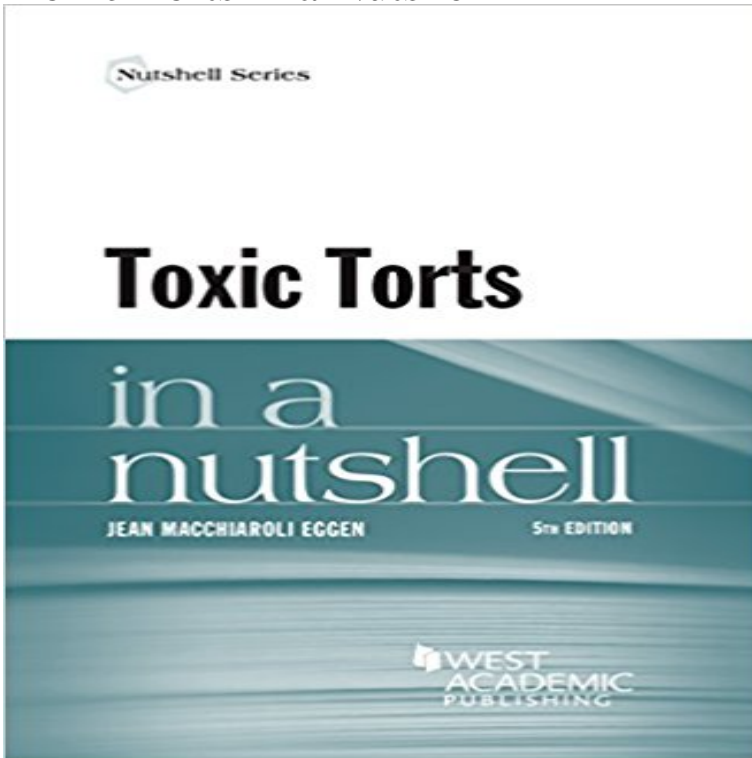


Toxic Torts in a Nutshell

The work also addresses mass toxic torts and examines emerging actions related to nanotechnology and hydraulic fracturing.
