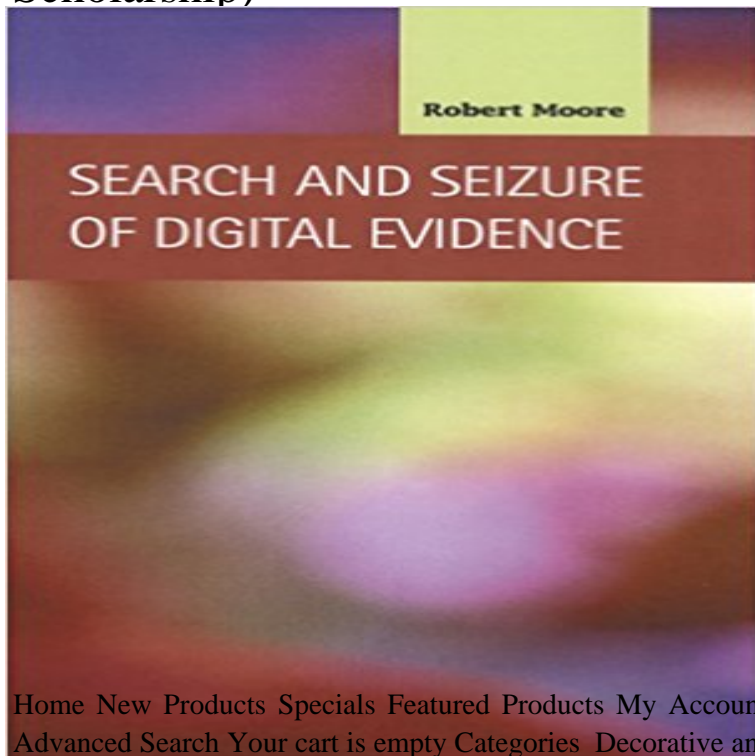


# Search and Seizure of Digital Evidence (Criminal Justice: Recent Scholarship)

To amplify his points, he discusses several high technology crimes. Additionally, he studies the nature of digital evidence in order to show how its volatile nature requires a greater understanding of when evidence may or may not be legally seized and searched.
