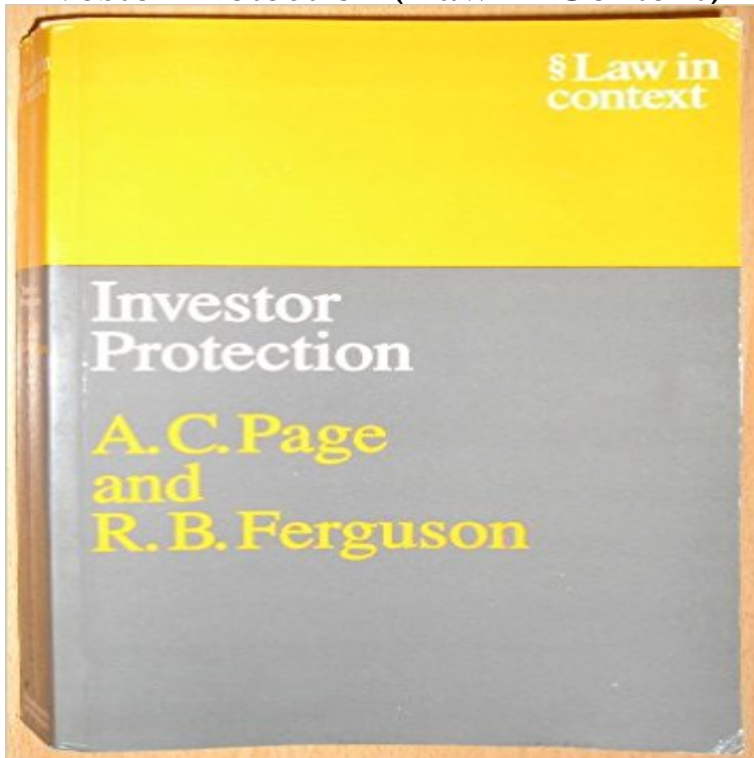


## Investor Protection (Law in Context)

The Chancellor of the Exchequer announced earlier that year that responsibility for banking supervision would be transferred from the Bank of England to a new strengthened Securities and Investment Board. More importantly, the latter will oversee a new and fully statutory system which will replace the financial services sectors current system of self-regulation.
