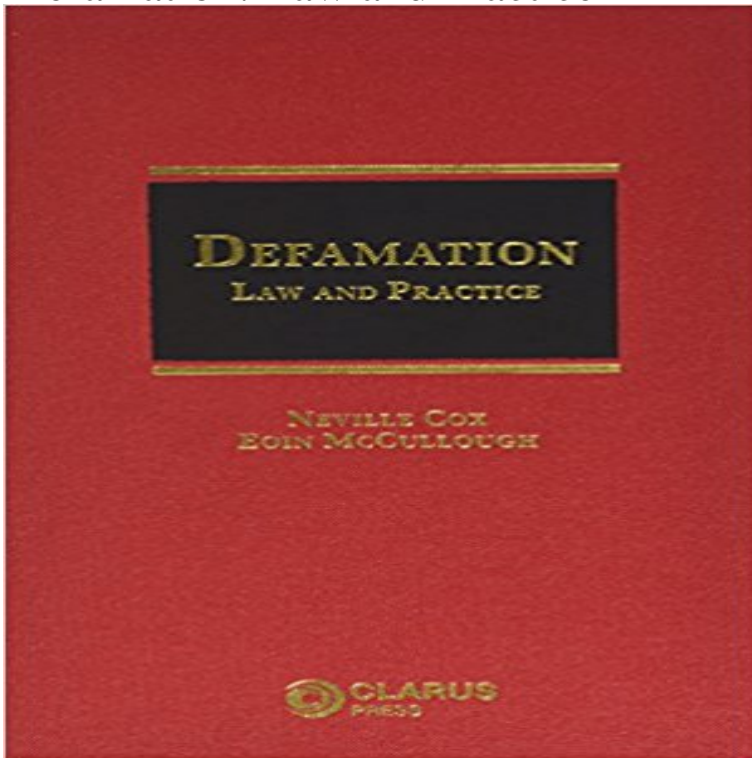


# Defamation: Law and Practice
