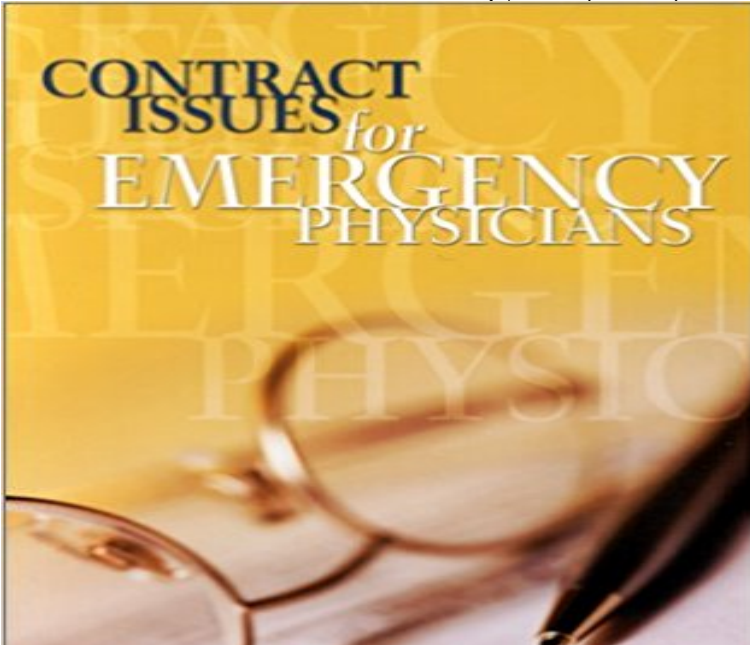


# Contract Issues for Emergency Physicians
