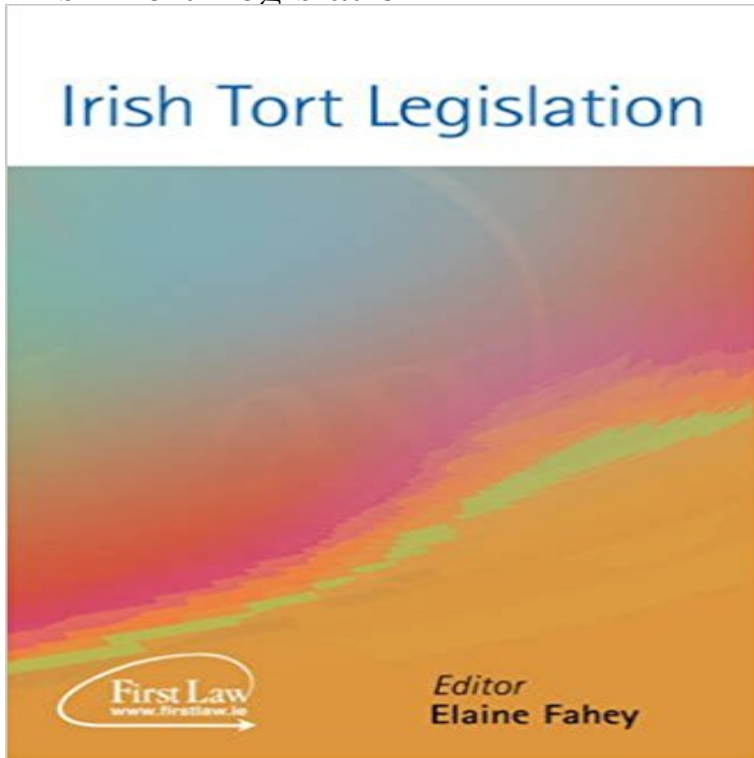


# Irish Tort Legislation
