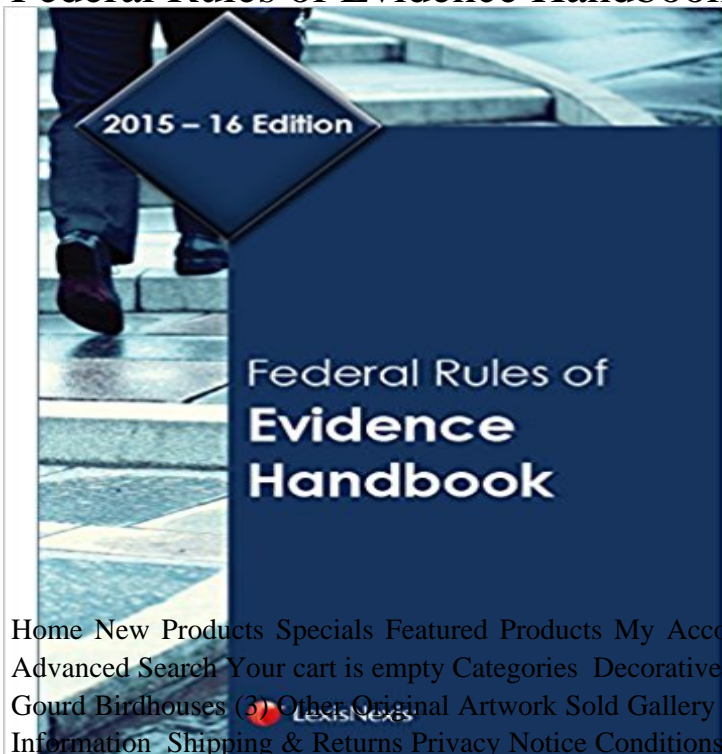


Federal Rules of Evidence Handbook (2015-2016)
