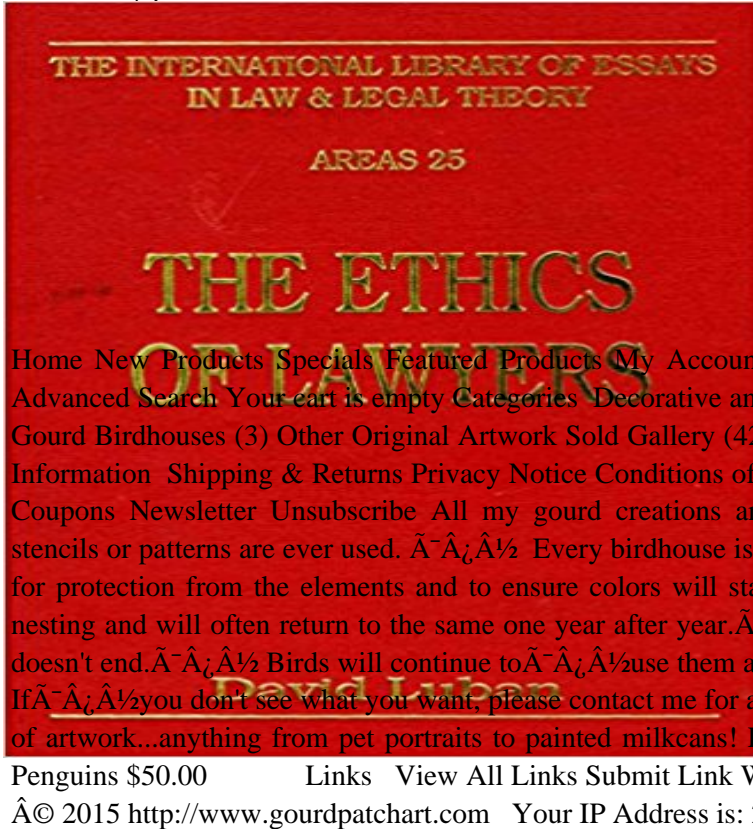


The Ethics of Lawyers (International Library of Essays in Law and Legal Theory)
