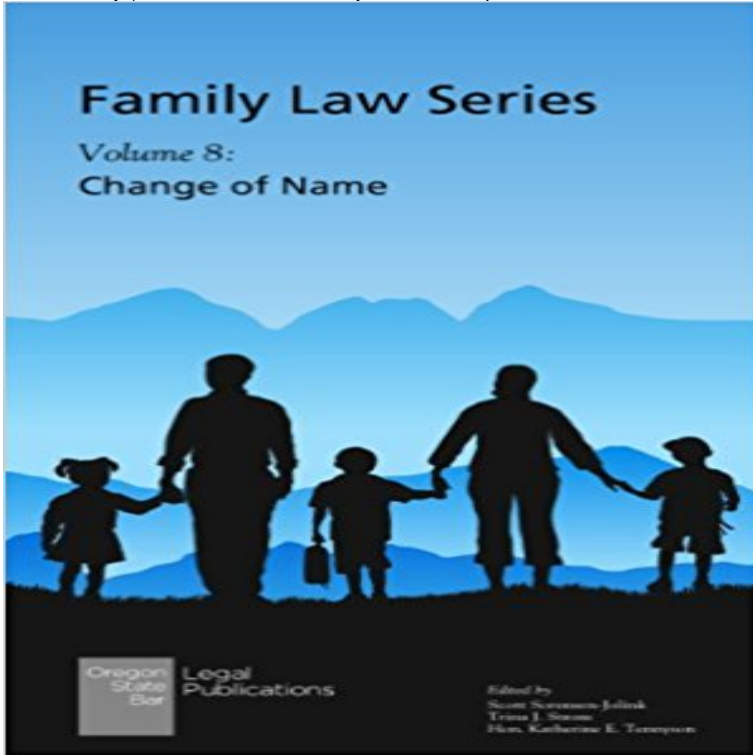


# Change of Name (Family Law Book 8)
