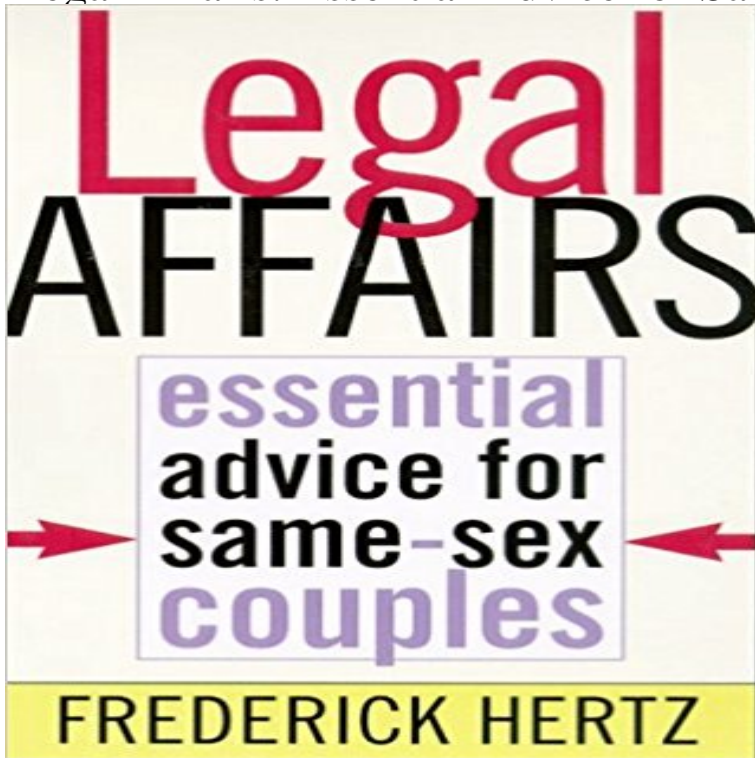


Legal Affairs: Essential Advice for Same-Sex Couples
