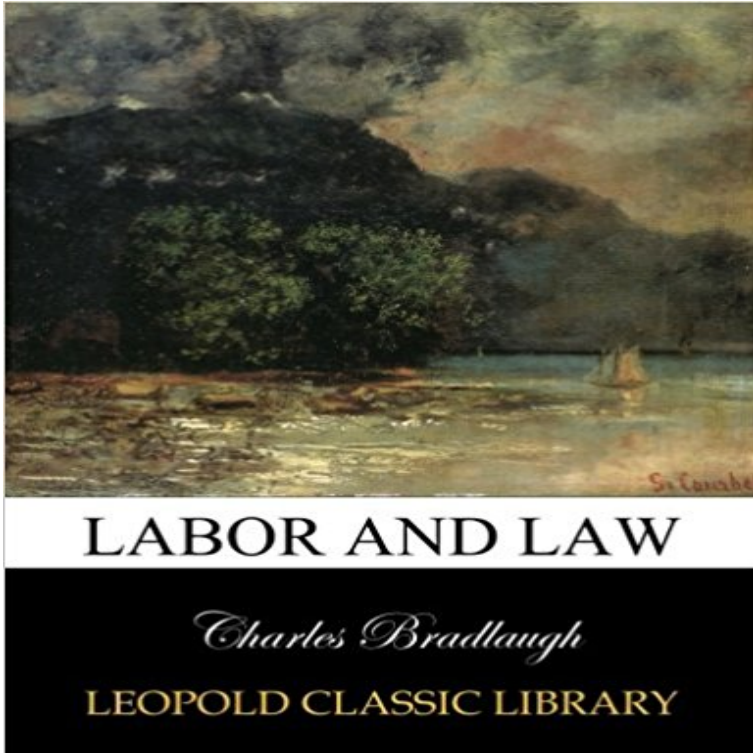


# Labor and law
