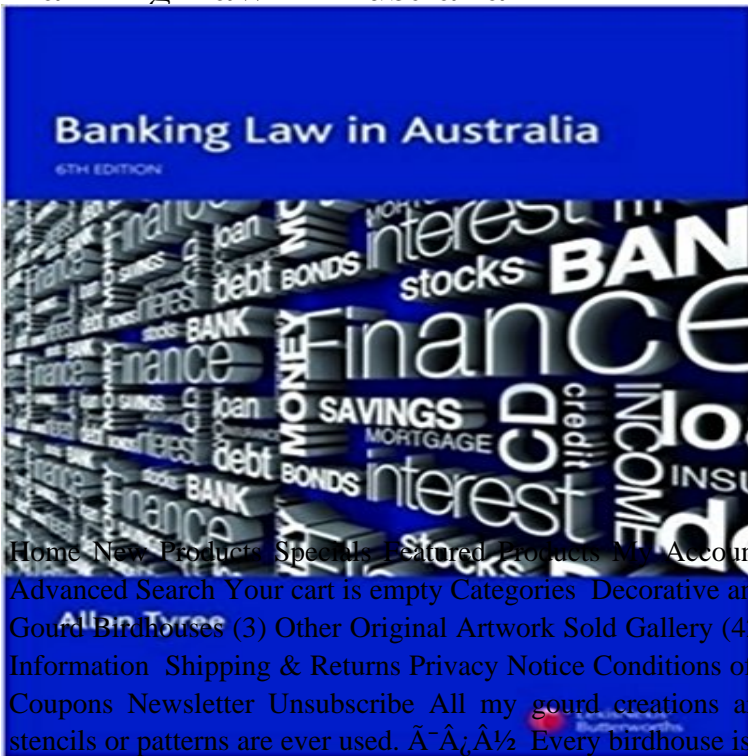


# Banking Law in Australia
