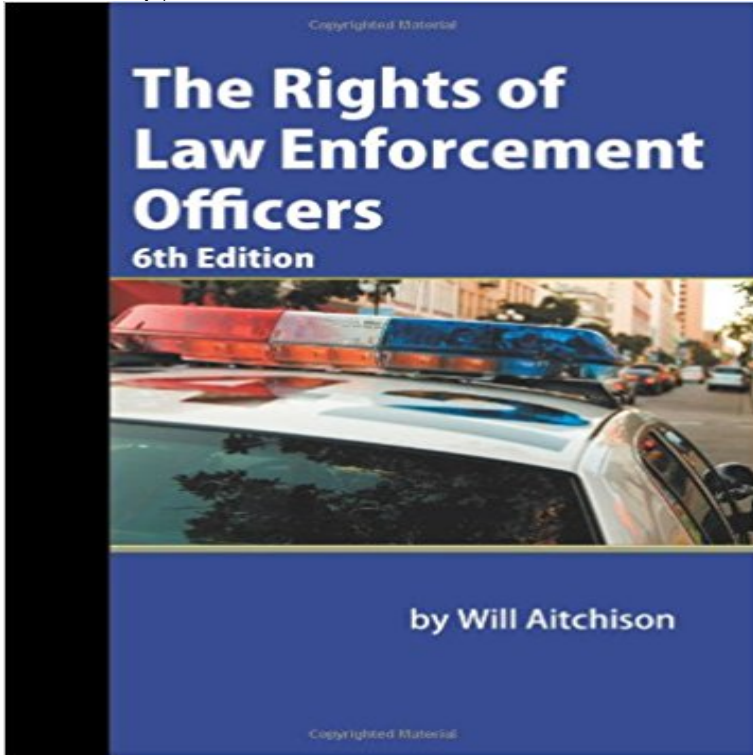


The Rights of Law Enforcement Officers
