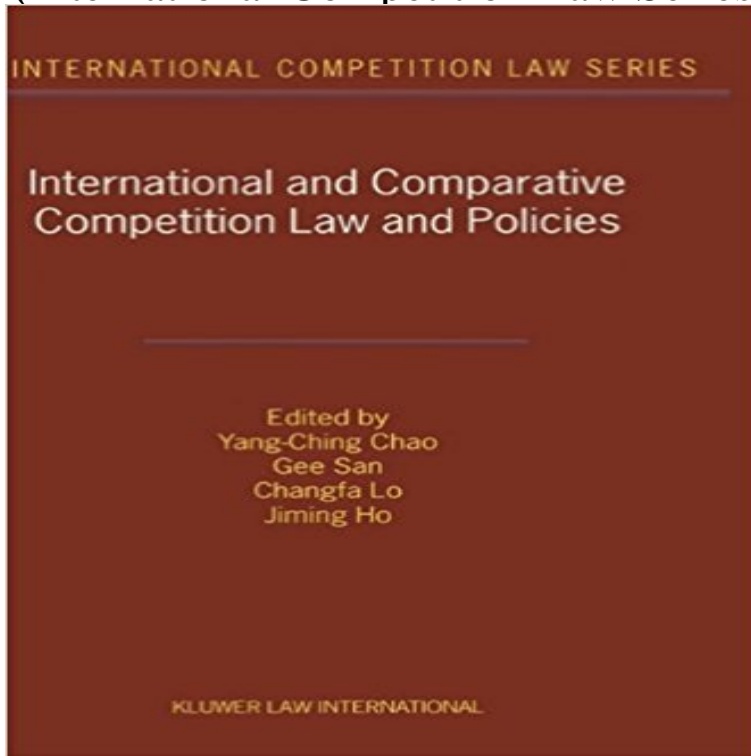


# International and Comparative Competition Laws and Policies (International Competition Law Series Set)
