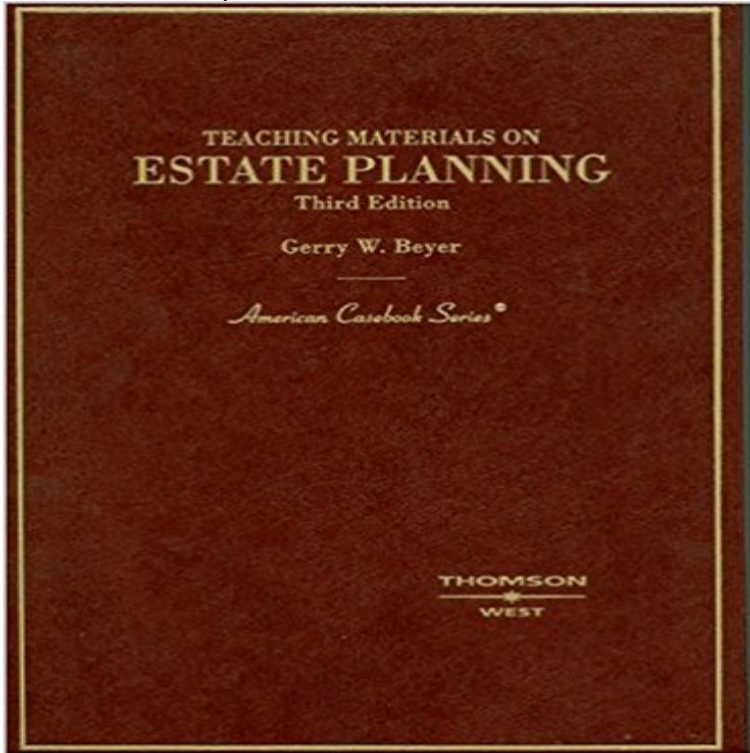


Teaching Materials on Estate Planning, Third Edition (American Casebooks)
