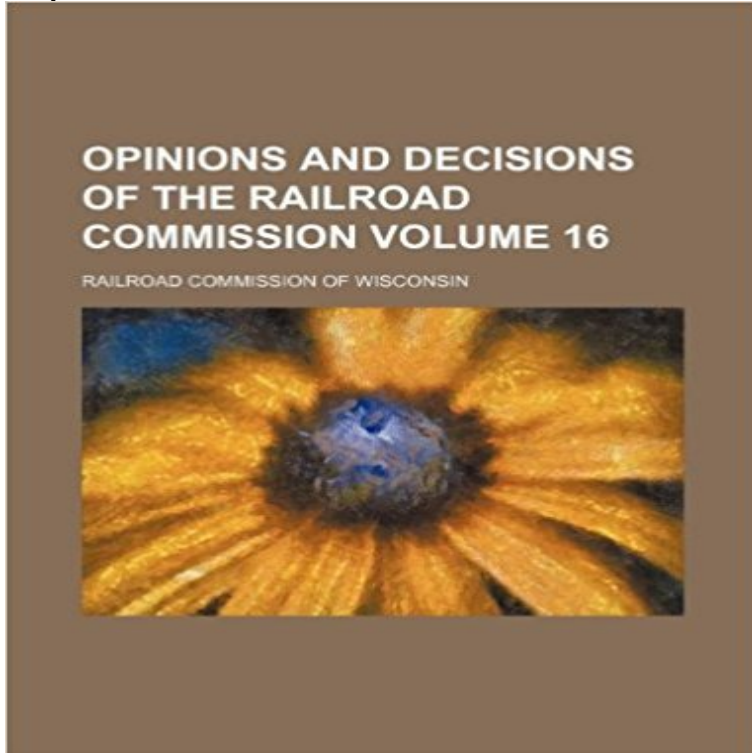


Opinions and Decisions of the Railroad Commission Volume 16

Not illustrated. 1915 Excerpt: ...with this Commission its local freight tariff known as C. & N. V. G. F.D. No. 12737-B, applicable to lumber in carload lots for manufacture and reshipment, with a minimum of 40,000 lb. to Antigo, Grand Rapids, Rhinelander, Wausau, and Kelley, from various stations in Wisconsin named in the tariff; that such rates show a substantial increase over existing rates; that such increase is unreasonable, unlawful, unequitable, and unjust; and that the petitioners protest against the increase as made. Hearing in the matter was held in the office of the Commission at Madison, on March 9, 1915. A. E. Solie appeared for the petitioner, and R. H. Widdicombe and H. C. Chycncy for the respondent carrier. The question here involved is identical with the one decided in Wisconsin Box Company et al. v. C. M. & St. P. R. Co. et al. 1909, 3 W. R. C. R. 605. At that time the Chicago & North Western and the Chicago, Milwaukee & St. Paul railway companies had made effective a tariff making a rate of 3 cts. on lumber for manufacture and reshipment from certain points to Wausau. Complaint was made by shippers and the Commission decided that the proposed increase was not justifiable under the circumstances. In discussing the question of cost that decision says (p. 616): The concentration rates in question, when standing alone, are somewhat lower than what might be termed reasonable rates for the services involved. While they yield quite a surplus above the operating expenses proper, this surplus is, perhaps, not quite as large as that which traffic of this nature should yield. But any deficiency in the surplus that may arise from the concentration rates is fully made up by the

rates from the concentration points to the market; for these rates are ample to take ...
