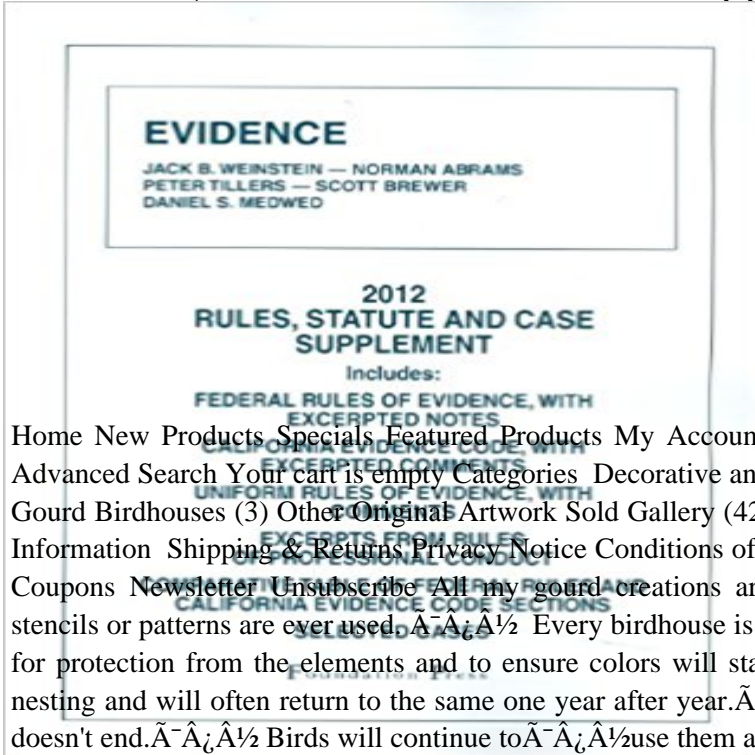


# Evidence, 2012 Rules and Statute Supplement
