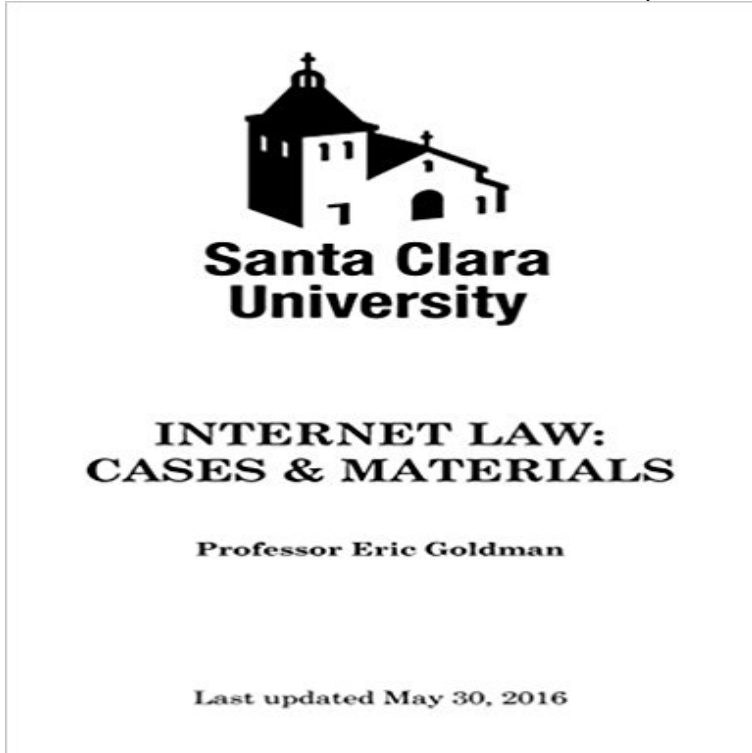


# Internet Law Cases & Materials (2016 Edition)
