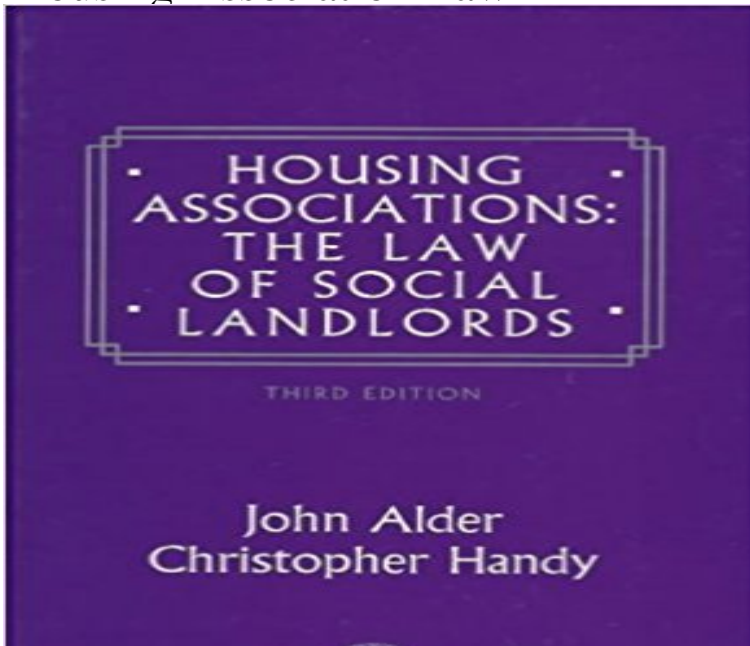


# Housing Association Law
