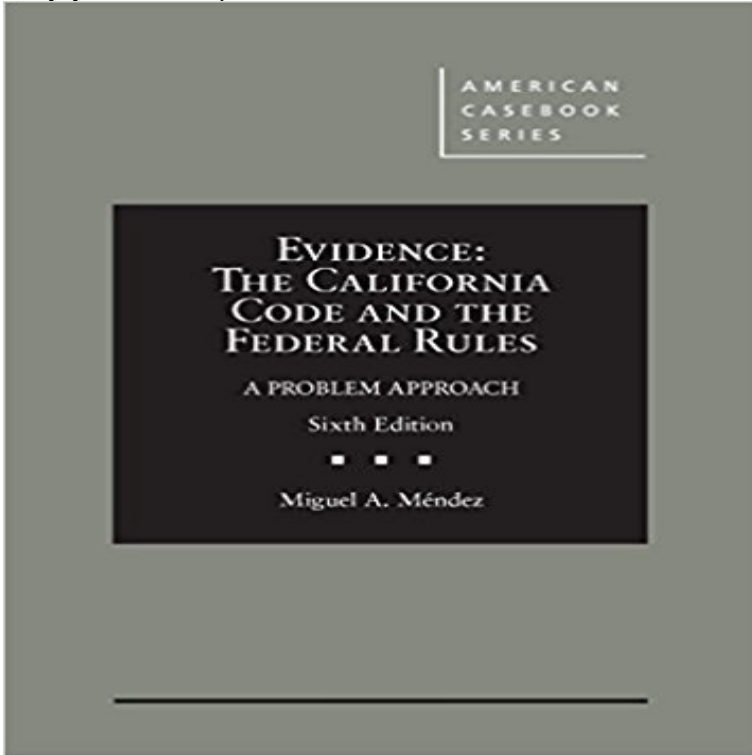


# Evidence: The California Code and the Federal Rules, A Problem Approach (American Casebook Series)
