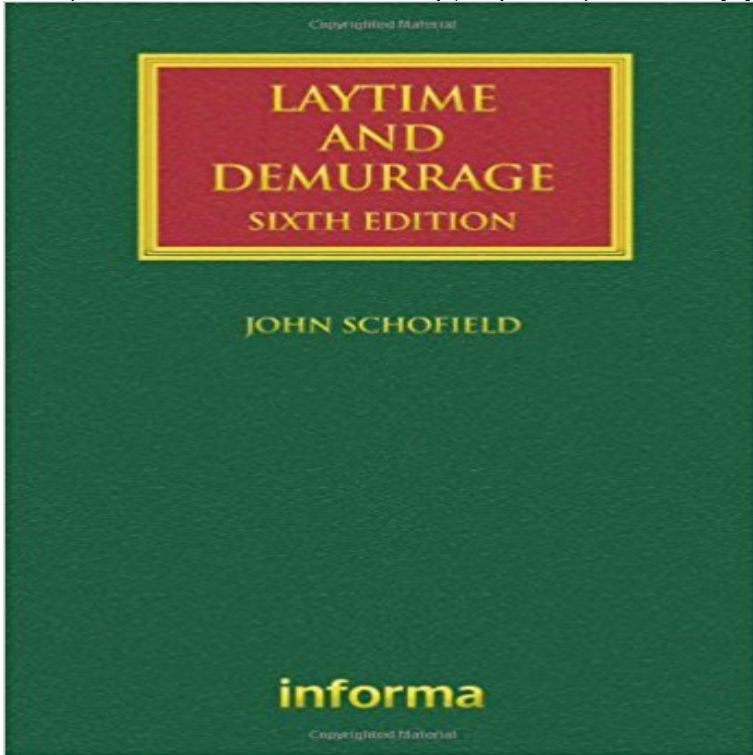


Laytime and Demurrage (Lloyds Shipping Law Library)
