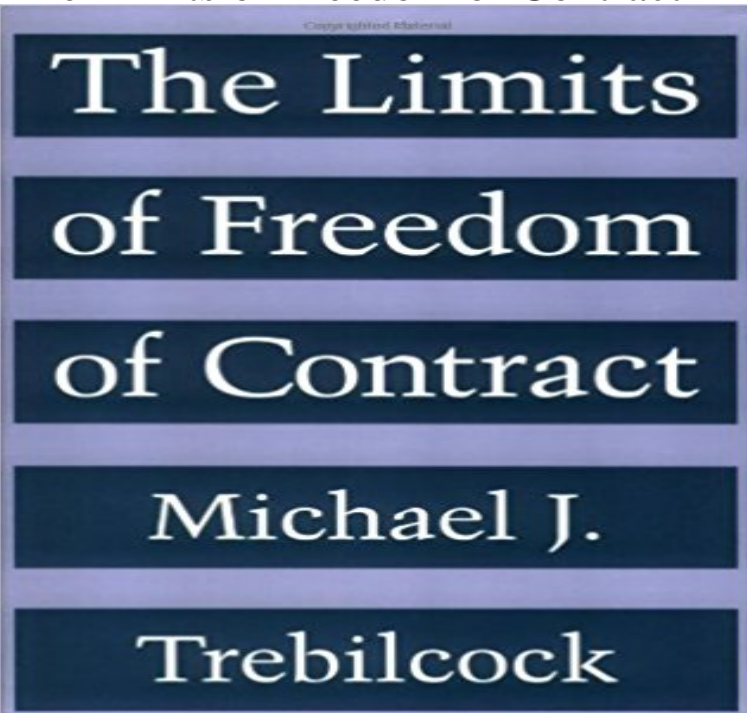


The Limits of Freedom of Contract
