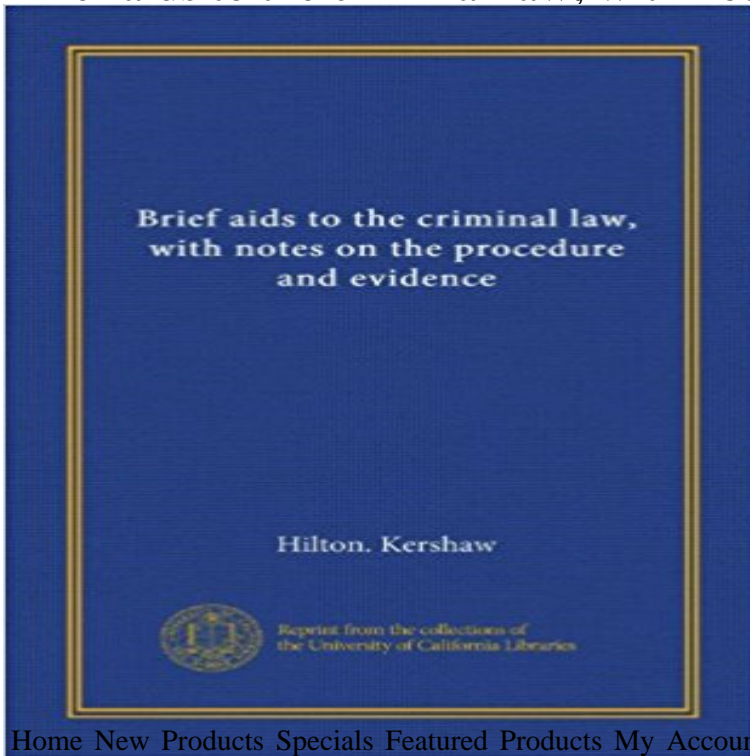


Brief aids to the criminal law, with notes on the procedure and evidence
