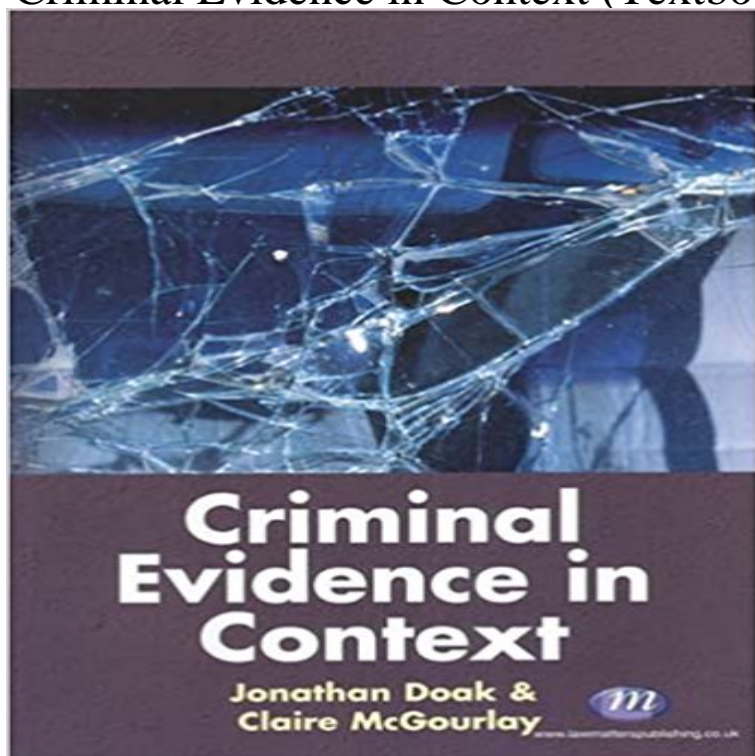


# Criminal Evidence in Context (Textbooks)
