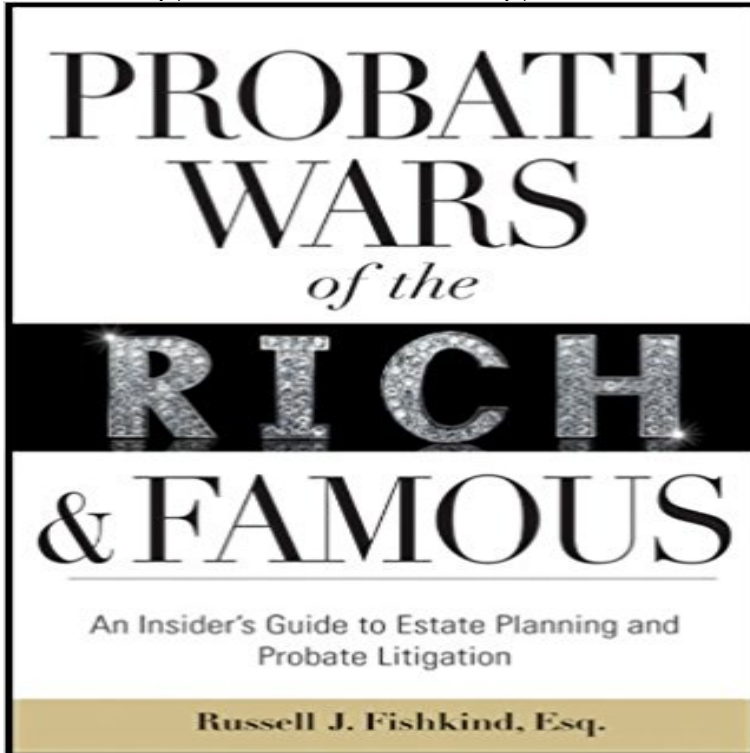


# Probate Wars of the Rich and Famous: An Insiders Guide to Estate Planning and Probate Litigation
