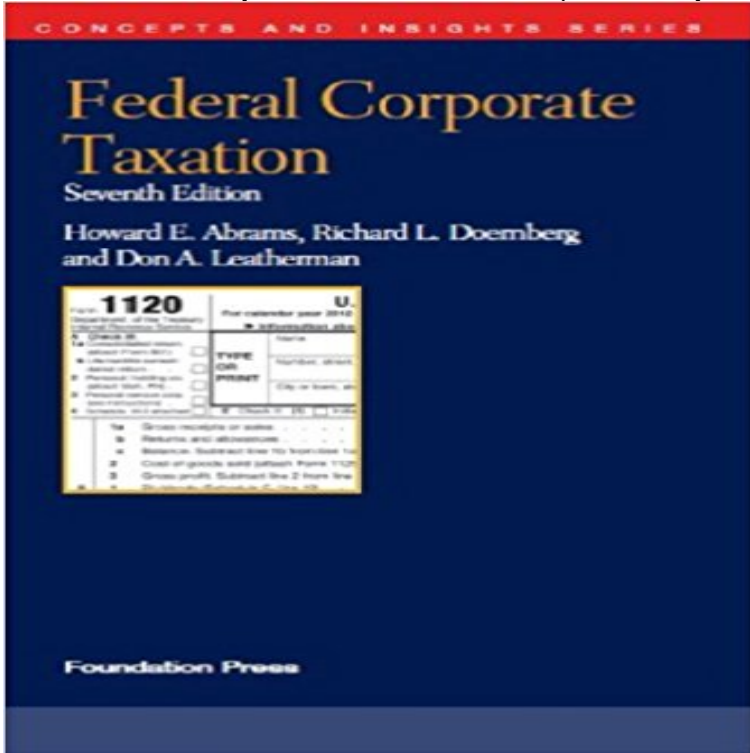


## Federal Corporate Taxation (Concepts and Insights)
