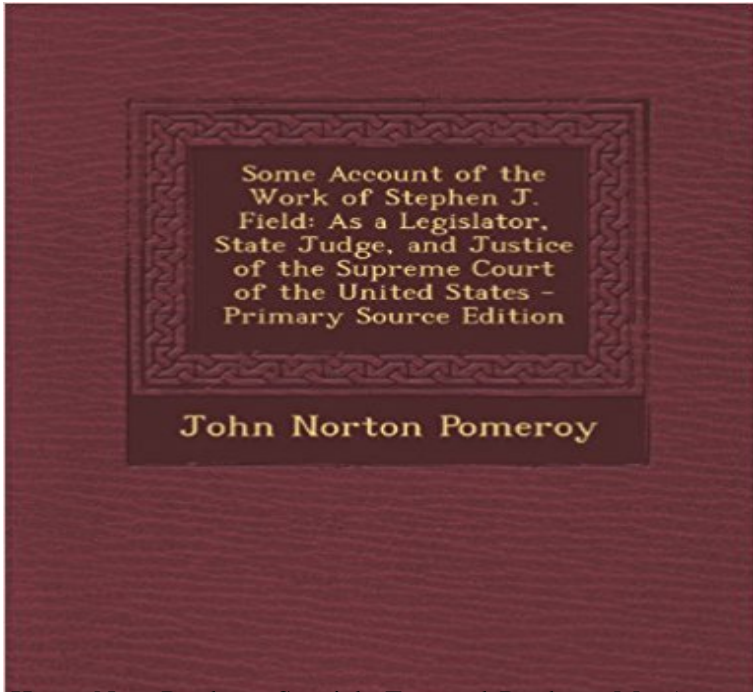


# Some Account of the Work of Stephen J. Field: As a Legislator, State Judge, and Justice of the Supreme Court of the United States - Primary Source EDI
