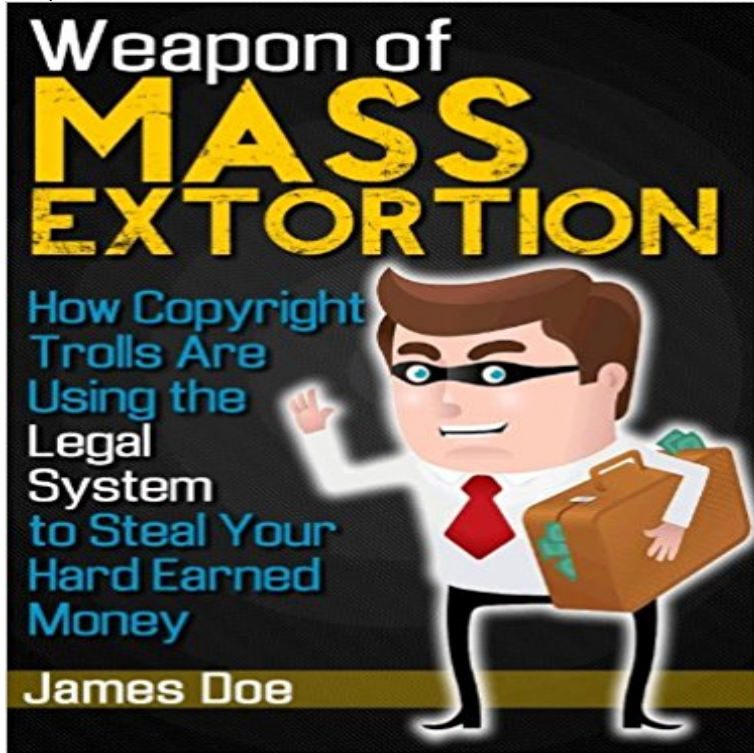


# Weapons of Mass Extortion - How Copyright Trolls Are Using the Legal System to Steal Your Hard Earned Money
