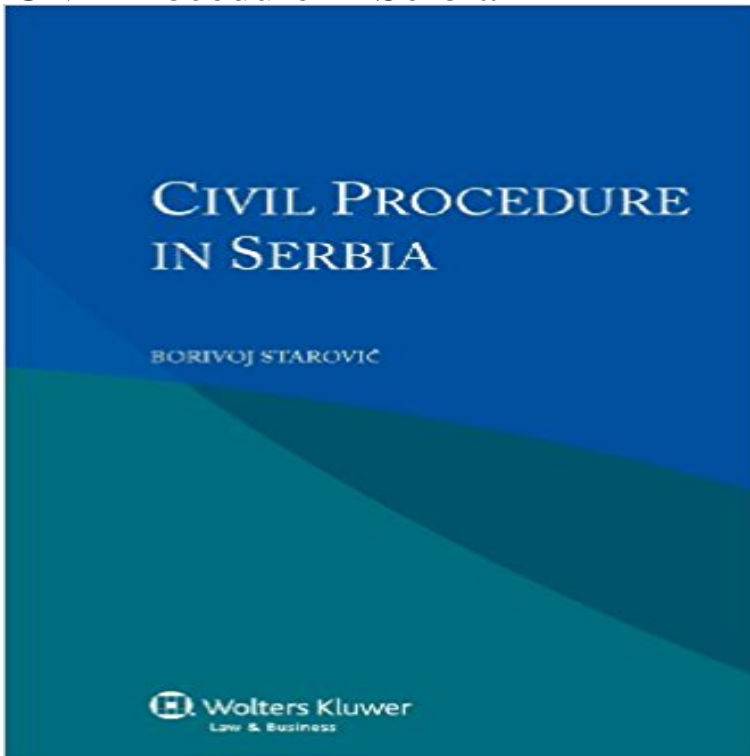


Civil Procedure in Serbia
