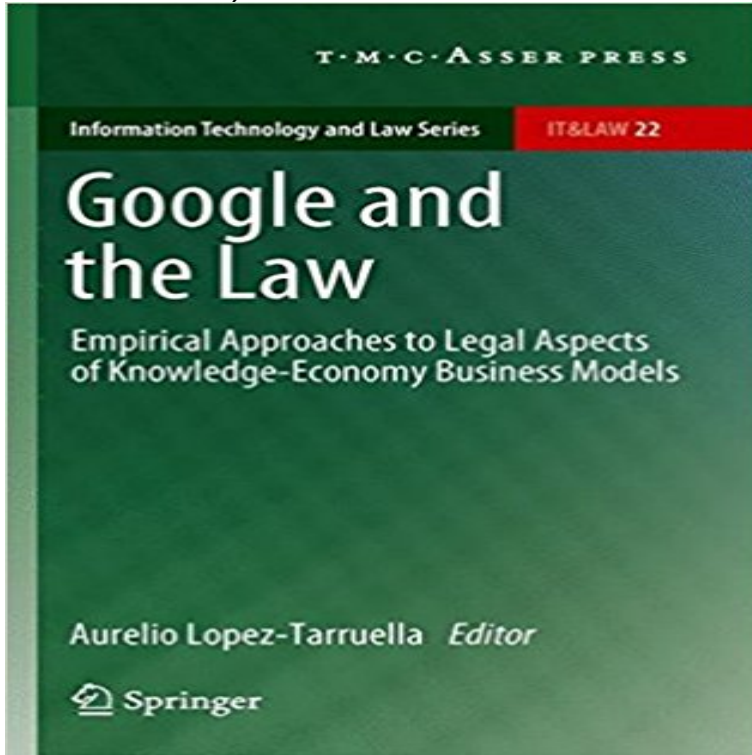


Google and the Law: Empirical Approaches to Legal Aspects of Knowledge-Economy Business Models (Information Technology and Law Series)

Or do they simply reflect that Google has gone too far? What lessons can other knowledge-based businesses learn from all the disputes in which Google has been or is involved? This book is valuable reading for legal practitioners and academics in the field of information technologies and intellectual property law, economists interested in knowledge-economy business models and sociologists interested in internet and social networks.
