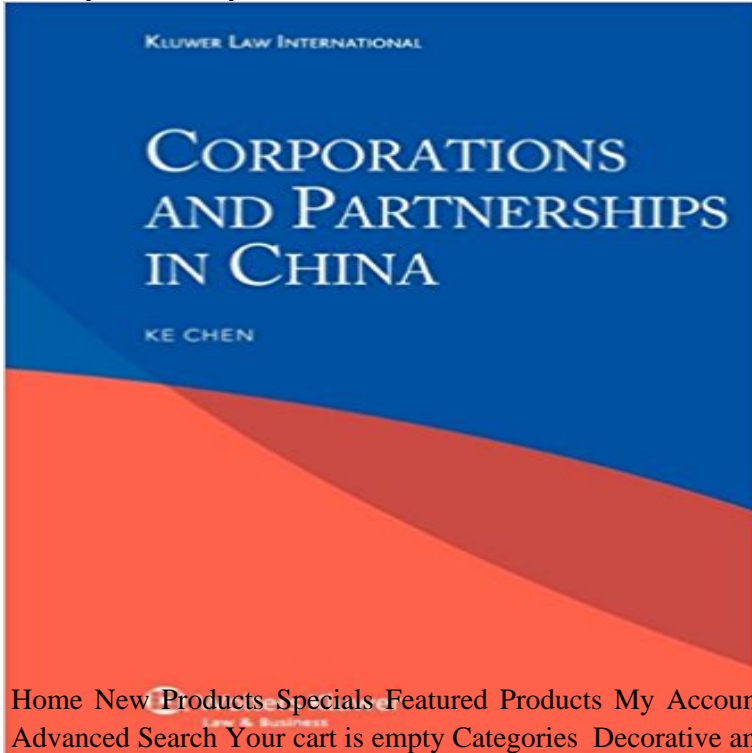


# International Encyclopedia of Laws, Corporations and Partnerships in the Peoples Republic of China
