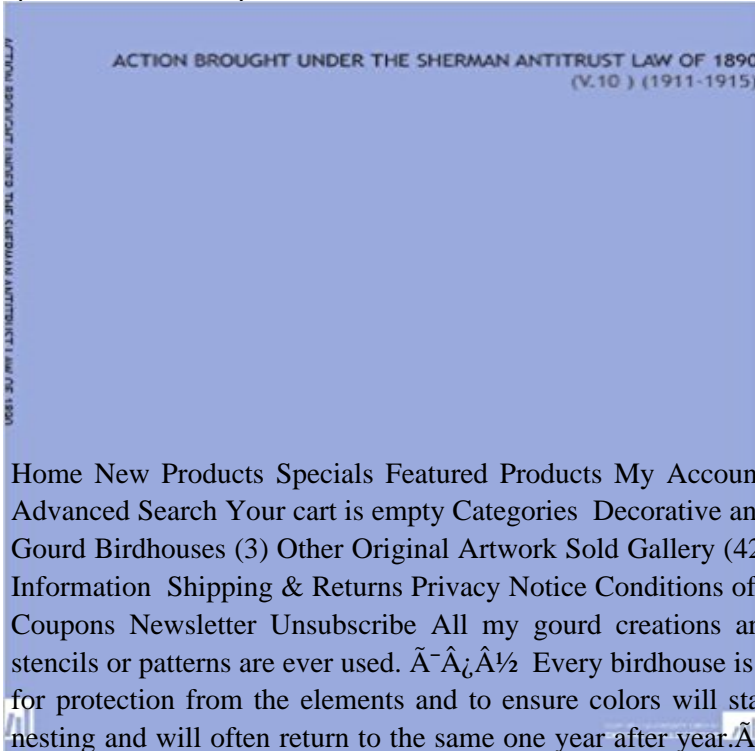


# Action Brought Under the Sherman Antitrust Law of 1890: (V.10 ) (1911-1915)
