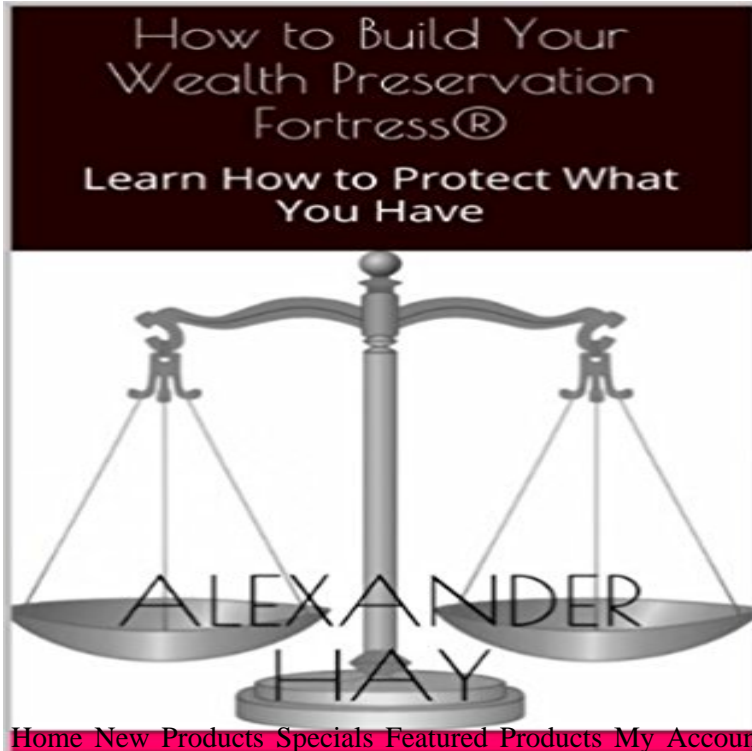


How to Build Your Wealth Preservation Fortress®: Learn How to Protect What You Have
