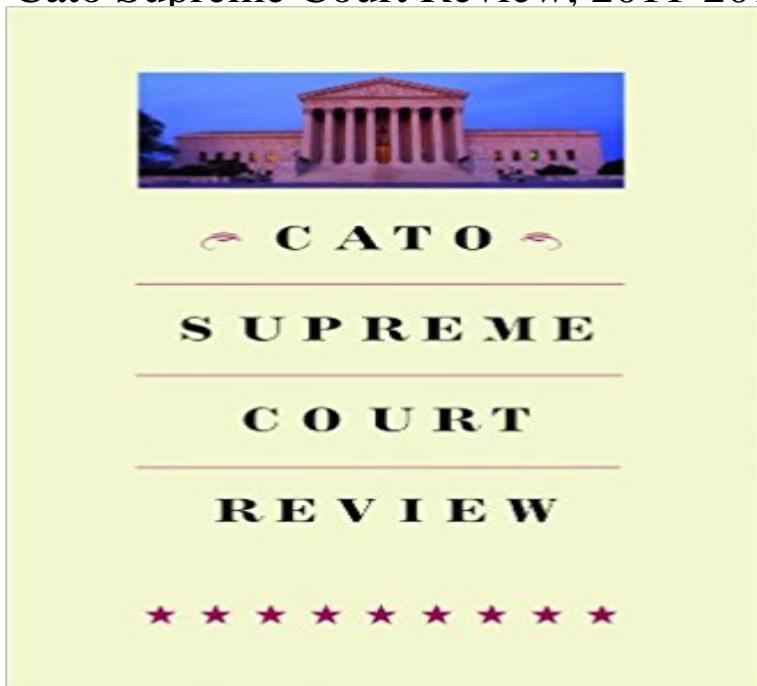


# Cato Supreme Court Review, 2011-2012
