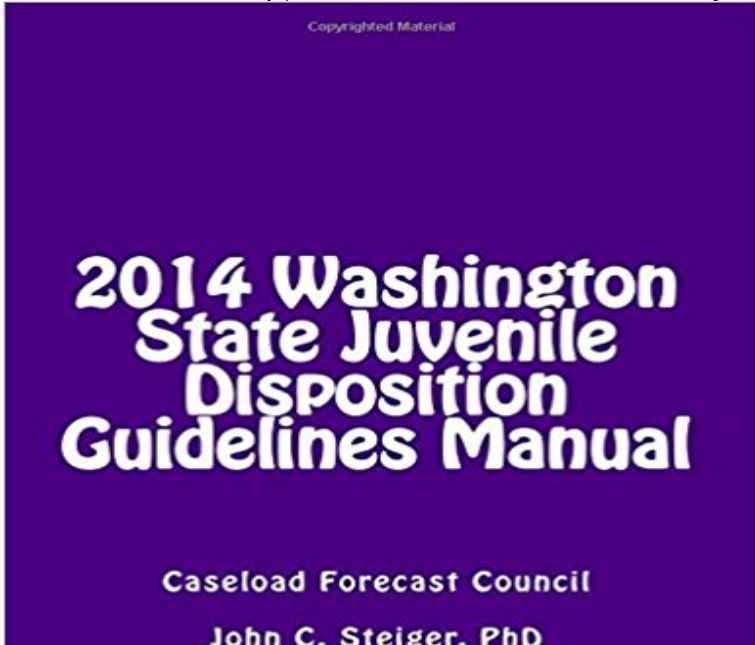


# 2014 Washington State Juvenile Disposition Guidelines Manual
