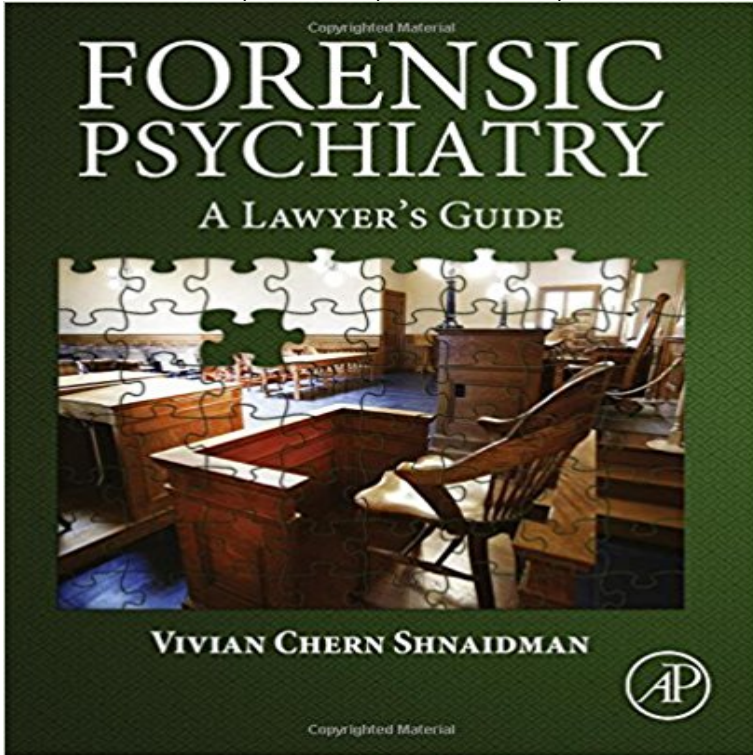


Forensic Psychiatry: A Lawyers Guide
